ARB APPLICATION 2017-8 - SAUL TAUB,

19 Pleasant Ridge Rd. New Hempstead, N.Y.

The Applicant is requesting approval of the design of an addition to his single-family dwelling. The property is located on the north side of Pleasant Ridge Road, 900 feet east from the intersection of Ash Lawn Ave. in the Village of New Hempstead, designated on the Town of Ramapo Tax maps as Section 41.20, Block 1, Lot 49 in a 1R-25 zone.

<u>Present</u> Mr. Taub Stanley Mayerfield, Architect

Mr. Mayerfield made the presentation. He presented a photo. The home is a "classic" Colonial with an extremely steep driveway. They plan to take down the garage and, in its place, build a new garage to the right and further back. This will gain distance and bring the garage closer to code. They are also proposing a 15' wide first and second floor extension in its place. A new 23' wide garage with a second story is being proposed on the far right of the house. Also, a new one-story addition is being proposed at the rear of the house. The total additional building coverage being proposed is about 1200 sq. ft. The existing siding, roofing shingles and windows will be removed from the existing structure and will be replaced with the same architectural elements that are being proposed for the new addition. The windows will be replaced with Anderson windows. There will be a new roof; Rusted Black, Tamko roofing. Siding will be gray vinyl; white trim around the windows, standard wide garage door.
