Correspondence Read into the Record Town of Ramapo, 1.8.2019 RC Sewer District, 1.15.2019 RC Department of Planning, 2.25.2019

Ira Emanuel, Attorney representing the applicant.

Ateres was originally granted 2 special permits. One for the construction and use of a permanent school building, and the other was for the interim school use. There are expiration dates that go with those special permits. The board granted an extension for the interim school until May 22, 2019 and now the applicant is requesting an extension on the permanent building until the end of August. We are also requesting that you override the county comments again because this is just an extension. There have been no changes that were made to these plans, and I have been in contact with them informing them of that. This is a complete overreach.

With respect to the outside events, that's part of the site plan approval and special permit approval. If a new owner takes over the site plan it will carryover.

With respect to parking, students are not permitted to drive to school, since this is a private school the school can and will take disciplinary actions if a student is found to violate the rule.
