VILLAGE OF NEW HEMPSTEADRESOLUTION CONCERNING A PROPOSED ACTION TO SELECT GOOD ENERGY, L.P. TO ACT AS COMMUNITY CHOICE AGGREGATION PROGRAM ADMINISTRATOR

WHEREAS, the VILLAGE OF NEW HEMPSTEAD desires to find ways to reduce electricity and/or natural gas costs for residential and commercial customers throughout the [VILLAGE OF NEW HEMPSTEAD;

WHEREAS, the VILLAGE OF NEW HEMPSTEAD **desires to adopt** and approve through local law a Community Choice Aggregation Program;

WHEREAS, the VILLAGE OF NEW HEMPSTEAD has been approached by Good Energy, L.P. regarding the possibility of Good Energy, L.P. acting as Administrator of the VILLAGE OF NEW HEMPSTEAD'S Community Choice Aggregation Program;

WHEREAS, the BOARD OF TRUSTEES of VILLAGE OF NEW HEMPSTEAD has determined that Good Energy, L.P. is qualified to act as Administrator of the VILLAGE OF NEW HEMPSTEAD's Community Choice Aggregation Program;

WHEREAS, the VILLAGE OF NEW HEMPSTEAD desires to work with Good Energy, L.P. to take any and all steps necessary and required by the New York State Law and policies, programs and orders of State administrative agencies to evaluate, negotiate and contract for the implementation of the Community Choice Aggregation Program if the VILLAGE OF NEW HEMPSTEAD determines the same to be in the best interests of the [MUNICIPALITY.

NOW, THEREFORE, BE IT RESOLVED, that the VILLAGE OF NEW HEMPSTEAD resolves as follows:

- 1. The BOARD OF TRUSTEES finds that the exploration of the potential use of Community Choice Aggregation in the VILLAGE OF NEW HEMPSTEAD is in the best interest of residential and commercial electricity and natural gas customers within the VILLAGE OF NEW HEMPSTEAD.
- 2. The BOARD OF TRUSTEES hereby approves Good Energy, L.P. to act as Community Choice Aggregation Program Administrator and authorizes the necessary [MUNICIPAL ENTITY officials to work with Good Energy, L.P. to conduct preliminary analyses, design programs, and procure electricity and natural gas service from an energy service company, as well as to take any and all steps necessary and required by the New York State Law and policies, programs and orders of State administrative agencies, including but not limited to conducting an RFP to select an energy provider, and to negotiate and enter into any such agreements including power purchase agreements to facilitate the implementation of the VILLAGE OF NEW HEMPSTEAD'S Community Choice Aggregation Program if the VILLAGE OF NEW HEMPSTEAD determines the same to be in the best interests of the VILLAGE OF NEW HEMPSTEAD electric and natural gas customers.
- 3. The DEPUTY MAYOR, and/or members of the BOARD OF TRUSTEES, as appropriate or as otherwise required by law, are hereby authorized, empowered and directed to execute and deliver such documents and take all such action on behalf of the VILLAGE OF NEW HEMPSTEAD as may be deemed necessary, appropriate or advisable to carry out the intent or purposes of the foregoing resolutions.
- 4. Attorney Minsky explained we will be separating this into three categories; Category 1 was something passed about 20 years ago and was in discussions for the last 5 years, only to be implemented now.

Category 1: Full Time employees + Mayor = 100% employer cost, up to a Family plan; if Village Clerk Treasurer retires from position coverage continues

Category 2: Board of Trustees= Individual coverage covered by employer with the option to upgrade to Family or Premium plan at the cost to the member.

Category 3: all other employees= 100% Voluntary Cost to the member

RESOLUTION NO.: BOT 2020-19 VILLAGE OF NEW HEMPSTEAD

TITLE: A RESOLUTION AUTHORIZING ENROLLMENT IN DENTAL AND VISION PLANS TO BENEFIT VILLAGE EMPLOYEES

WHEREAS, by prior Resolution, the Village Board previously authorized certain benefits for Village Officials and employees that qualified for health benefits; and

WHEREAS, the prior Resolution did not address certain issues regarding benefits for Village employees needing vision and dental insurance; and

WHEREAS, the Village Board recognizes that in order to keep and maintain employees that deliver high levels of services to the residents of the Village of New Hempstead, the Village must reward its employees by providing competitive benefits; and

WHEREAS, the Village received several different plans that would provide vision and dental insurance to Village employees; and

WHEREAS, the Village Board reviewed and compared the various plans and costs and determined that the plan submitted by MetLife's Preferred Provider Organization ("PPO") is the most cost effective and beneficial to address the needs of providing vision and dental coverage to Village employees;

NOW THEREFORE, it is hereby

RESOLVED, that the Village Board of the Village of New Hempstead hereby approves and authorizes the Village to enroll in the MetLife PPO Gold Dental Plan and the MetLife High M150A-0/0 Vision Plan, and it is further

RESOLVED, that enrollment in the aforementioned vision and dental plans is available to all current and future employees of the Village with the following the following categories to determine the amount and type of benefit provided by the Village of New Hempstead:

<u>Category #1:</u> All full-time employees and the Mayor the Village of New Hempstead shall pay 100% costs up to a Family vision and dental Plan coverage under the aforementioned plans.

<u>Category #2:</u> All members of the Village Board of Trustees - the Village shall pay to the respective providers a monthly premium for individual coverage for each Trustee. Each Trustee may have the option of upgrading to a family or premium plan at his/her own additional expense.

<u>Category #3:</u> All other employees of the Village may enroll in either or both plans with a 100% voluntary cost to such employees. The Village shall not make any contribution for premiums under this category; and it is further

RESOLVED, that the instant Resolution shall be applicable to current and future employees and Officials of the Village with no benefit conferred on past employees; and it is further

RESOLVED, that in the event any participant covered under this Resolution chooses not to enroll, participate or otherwise use the benefits bestowed hereunder, then the Village shall not make any monetary payments in lieu of premiums to said employee or Official; and it is further

RESOLVED, that if/when the Village Clerk Treasurer retires from the position coverage continues; and it is further



RESOLUTION REQUESTING AMENDMENTS TO New York STATE'S CRIMINAL JUSTICE REFORMS

Trustee Reich offered the following motion, which was seconded by trustee Eisenstein;

RESOLUTION OF THE **VILLAGE OF NEW HEMPSTEAD**REQUESTING AMENDMENTS TO New York STATE'S CRIMINAL JUSTICE REFORMS

WHEREAS while there was a need to reform New York's criminal justice statutes during the 2019 state legislative session, it is widely recognized that several of the drastic changes in the laws pertaining to discovery are overly broad and vague and are having unintended consequences at the municipal level; and

WHEREAS the dramatically shortened time period in which prosecutors must disclose evidence to defendants and the broad expansion of the matters to which such discovery mandates apply will have significant cost, tax and justice implications for cities and villages with police departments, local justice courts or code/parking enforcement departments; and

WHEREAS the discovery reforms mandate prosecutors disclose evidence to the defense within 15 days of arraignment for criminal charges (even if the defendant is not in custody); and

WHEREAS drastically enlarging the scope of material that a prosecutor must review and deliver within 15 days will overwhelm the ability of city and village officials and employees to prosecute cases while managing their misdemeanor and felony caseloads, and will make it impossible to prosecute vehicle and traffic and local code infractions and violations in compliance with the new discovery mandates; and

WHEREAS arraignment must now take place within 20 days of desk appearance ticket issuance, thereby requiring justice courts, many of which convene monthly, to meet more frequently; and

WHEREAS cities and villages will not reap savings from the bail reform's reduction of the burden on county jails; and

WHEREAS municipalities are already challenged with operating within the now-permanent 2% tax cap and have not received an increase in general purpose state aid in 11 years.

NOW THEREFORE BE IT RESOLVED THAT the *VILLAGE OF NEW HEMPSTEAD* supports the following set of amendments proposed by the New York State Conference of Mayors that are consistent with the intent of the criminal justice reforms but which will allow for more effective and affordable implementation:

 Ensure that cities and villages are provided with additional financial and operational support to offset the cost of these mandated measures;

- Allow 60 days for prosecutors to disclose evidence to the defense for criminal charges;
- Exclude from the accelerated discovery requirements any charge not involving a misdemeanor or felony;
- Adjust the 20-day arraignment requirement to accommodate local courts that meet on a monthly basis;
- Allow prosecutors to withhold sensitive information, such as victim contact information, without having to obtain a court order.

AND BE IT FURTHER RESOLVED that this duly adopted resolution of the *VILLAGE OF NEW HEMPSTEAD* be forwarded to Governor Andrew Cuomo, Senate Majority Leader Andrea Stewart-Cousins, Assembly Speaker Carl Heastie, Senator *CARLUCCI* and Assembly Member *ZEBROWSKI*, the New York State Conference of Mayors, and local media outlets.
