Discussion- Ashlawn Ave Petition

Avi Weinstein, 13 Ashlawn Ave

Ashlawn is a very long street that people tend to speed down. Many of the neighbors are concerned for their safety. We have joggers in the area, a lot of children and we really like your idea of temporary humps if that doable. With possible signage for the months when the speed humps aren't there. We appreciate the board taking this seriously and placing it on the agenda.

Eliezer Drew, 10 Ashlawn Definitely in Favor of Speed Humps but no Stop Sign.

Dov Oliver, 7 Ashlawn Ave I have witnessed a lot of close calls and appreciate anything that can be done.

Greg Jordan, 21 Ashlawn Car are definitely flying by faster then ever before. I do not want stop signs but I do think the speed humps are a great idea.

Ahron Faymen, 118 Grandview Ave Over the last few years the speeding keeps getting worse.

Devora Drew, 10 Ashlawn

Overtime the speeding has been getting worse and worse. I don't even let me kids go into the street to ride their bikes without me next to them.

Steven Bermin, 9 Ashlawn Ave

Extremely rare that we see an officer on this street. I think first they should try and have the Police bring down the speeding.

Mayor Sicker stated he and the Village engineer will go out to Ashlawn to monitor and come up with a solution

Discussion-Sandybrook Safety

Mayor Sicker explained at the last meeting it was brought up that there was an issue with speeding on Sandybrook Dr. Since the last meeting there has been a cop issuing tickets in the area. The Village wants to spread awareness that speeding and reckless driving is not acceptable and they will be ticketing people going 10 over the speed limit.

The conclusion the Village came to for the speeding by Summit Park Pd and Pennington Way we are placing temporary Speed Humps. A speed Hump vs a Speed Bump is you go onto it and gradually go down vs a Bump would be abrupt and is illegal. They will be placed on an as needed basis and relocated as needed.

Sandybrook is a little more complicated because its not a straight road. We are still discussing our options.

Sally Winter, 38 Sandbrook

There's a bend on Sandybrook that people speed when they go around and at the other end of the bend children are riding their bikes in the street. Its extremely dangerous. I think that a Speed Hump before the bend would be a good idea.

Leah Sobal, 34 Sandybrook Agrees with everything Mrs. Winter said.

William Greenfield, 29 Sandbrook Dr. Is there any way to first try something a little less invasive? Maybe Slow Down Children at Play or a Speed Limit sign.

Sally Winter Signs wont work.

Sunday Gurber, 27 Sandybrook Drive I have an issue when people come down Pennington Way and get to the yield. It should be changed to a stop sign.

Mayor Sicker agreed.

Mr. McCreedy wants to discuss potentially adding another stop sign.

Mayor Sicker will go with the Village engineer and a trustee to come up with a solution.

There are two sides to this discussion. Yes there is an issue with speeding, and you can add humps or Officers to ticket but another issue is the children riding their bikes in the middle of the street. This needs to be addressed on both sides drivers should definitely slow down and be careful going around the bend, but the kids also have to be careful.

- Pennington Way-install stop bars.
- Pennington Way-Change the yield sign at the north end of Pennington to a three way stop.
- Pennington Way/ Summit Pk Rd- speed humps
