- 9.4.3 <u>Public Hearing</u>: The Board of Appeals shall conduct a public hearing on any appeal, application or request made pursuant to this Local Law. Such Public Hearing shall be held within 45 days of the date an appeal is taken or an application or request is made to the Board.
- 9.4.4 Notice of Hearing: Notice of the hearing shall be published in the official newspaper at least 10 days prior to the date of such hearing. Notice shall also be sent by the applicant 10 days prior to the date of such hearing, to all property owners within 500 feet of the perimeter of the property, in the same manner as is required for amendments, pursuant to Section 13.7 of this Local Law. The applicant shall cause signs to be posted on such property on each street frontage indicating the date and property on each street frontage indicating the date and purpose of such hearing. The cost of all such notice shall be paid by the applicant.
