Brief Description of Proposed Action (include purpose or need):  Development of up to 325 Single Family residences on 149 acres in the Village of New Hempstead. The project site is currently in use as the NY Country Club, an 18-Hole golf course. The single family development will replace the golf course. Development will require creation of a new zoning category to be known as 1R-10, which permits development of a single family residence on a minimum lot size of 10,000 square feet. The development will include road improvements as warranted. The site includes natural and man-made water bodies. The two large water bodies will be preserved and become part of the site development. The small man-made water areas will be filled as part of the development. No disturbance will occur to any of the on-site wetland areas, which will be preserved in their entirety. A full stormwater pollution prevention plan will be developed to ensure there is no increase in the rate or volume of stormwater leaving the site. The site is currently serviced by both municipal water and sewer.

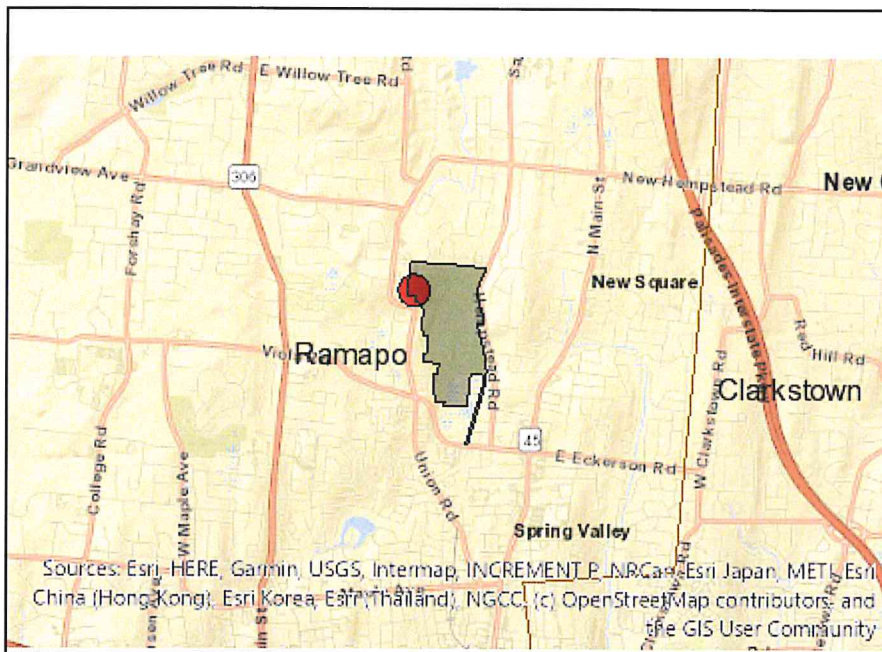

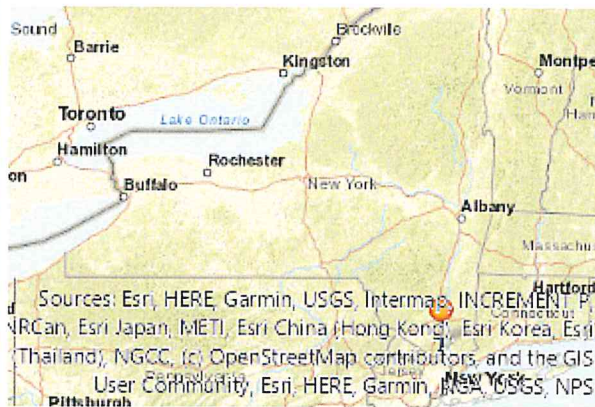
