## **Description of Action:**

The subject application is for a two-story addition to the rear of an existing two-story office building. The 2.9-acre (126,998 square foot) lot currently contains a 26,885 square foot building and a parking lot with 113 spaces. The Applicant is proposing a two-story 18,554 square foot addition on the rear of the building. The Applicant proposes to decrease the physical parking spaces provided at the site from 112 to 102, and to create 37 reserved spaces (to be unbuilt at this time). This would create a potential for 139 parking spaces post-construction if all reserved parking were built.

<u>Location</u>: The project is located at 775 North Main Street at SBL# 42.18-2-24, in an NCD Neighborhood Commercial district, that was approved by the Village Board of Trustees in October 2023.
